## **NSGC Research**

- NSGC Research, Quality and Outcomes (RQO) Committee: RQO issued an RFP in support of its 2024 Research Initiative around reproductive healthcare. An award will be made in July 2024.

- Jane Engelberg Memorial Fellowship (JEMF)
  - The JEMF provides support for research projects that drive innovation in the field of genetic counseling. The 2024 Full Member Award application has closed, and the JEMP advisory group will meet in June to select the winner.

- <u>Audrey Heimler Special Project Fund Award (AHSPA)</u>
  - The Audrey Heimler Special Projects Award is an annual grant that funds a project or research focusing on the future of the genetic counseling profession and/or the provision of genetic services. The application deadline is May 13, 2024.
- o NSGC Special Interest Group (SIG) Research Grant Awards
  - The SIG Grant Awards are supported and funded by NSGC to seed research by members of NSGC's Special Interest Groups in specific areas of specialization. For 2024, research awards have been made to the NSGC Cancer, Cardiology, Neurology, International, and Research Special Interest groups.

## NSGC Journal of Genetic Counseling (JoGC)

- <u>New Editorial Board</u>: The JoGC editorial board has been refreshed with <u>new members from around the world</u>, including the Philippines, Japan, India, Romania, Switzerland, Australia, South Africa, the UK, Canada, and the USA.
- The structure has also changed, with a focus on review for methodological rigor. Four deputy editors two handling qualitative manuscripts, and two handling quantitative manuscripts report to the Editor in Chief, together with two Directors of DEI integration, and four new editor-at-large positions for trainees.
- <u>New Scope Statement</u>: The editorial board updated the <u>scope statement for the JoGC</u>, and is working on an updated DEI statement.
- <u>New JoGC Podcast Series</u>: JoGC has launched a <u>podcast series</u>, "DNA Dialogues: conversations in genetic counseling research," with each episode focused on two recently published JoGC papers and in -depth conversations with the



authors.

- <u>Special Issue on Research Methods</u>: JoGC is currently launching a call, and soliciting papers for a special virtual issue of the journal on Research Methods in Genetic Counseling.
- <u>Collaborative Nature Genetics/JAMA Paper</u>: JoGC collaborated with other genetics journal editors on a co-authored paper published in Nature Genetics/JAMA about <u>genetic ancestry</u>.
- <u>CGA-IGC Collaboration</u>: The JoGC is working with the Collaborative group of the Americas on inherited gastrointestinal cancer (CGA-IGC) on publishing a "best GC paper" simultaneously with their conference.
- <u>English Language Assistance</u>: JoGC is launching a volunteer led program to provide assistance to authors who cannot afford the publisher language editing services but need assistance with language and grammar.
